Appointment Letter

of the Parish Priest to The Romanian Orthodox Parish of **Saint Dimitrie, Easton, Connecticut**

This letter is to announce to you the appointment of the **Reverend Father Alexander Daniel Bitis** to the Office of Parish Priest effective **December 01, 2024.**

Father Bitis has been appointed your Parish Priest according to Article I, Section 3, (a). Father has agreed and accepted this appointment, and he also accepted the remuneration and the benefits which were offered by the parish.

With the appointment of a Parish Priest, you, the faithful have a spiritual father and parish administrator among you. The Priest is assigned in the parish with the understanding that he and the faithful are one family and the parish works as one unified body.

The Parish Assembly, and the Parish Council which is elected by the Assembly, work together with the priest for there is no separation of the spiritual and the material blessings of the parish. The Priest is not solely for the altar but also has responsibility for administration as head of the Parish Office Article IX, Section 18 & g.
